This appeal involves a split of a double issue. On the one hand, appellants claim that the trial court erred in directing verdicts in favor of appellees as to Counts I, II, and III of appellants' complaint; on the other hand, appellants argue that the trial court erroneously directed verdicts in favor of appellees as to appellants' prayer for equitable relief. As to appellants' attack on the directed verdicts for appellees on Counts I, II and III, our examination of the record and the briefs discloses that the matters presented were fairly litigated. As to the equitable relief issue, the uncontroverted testimony revealed the following: The alleged collision occurred on August 21, 1972. Appellants filed their complaint on June 16, 1973. Their original complaint was for alleged negligence on the part of appellees. Appellants amended the complaint to allege nuisance, trespass and interference with prospective trade. The amended complaint was filed on July 3, 1973. A pretrial conference was held on August 13, 1973. A pre-trial order, which was entered September 3, 1973, among other things, stipulated that the trial would proceed on the issue of liability, but that the issue of damages would be tried by the jury at a later date. Pre-trial conferences were held on September 17, October 8, October 18, October 29, November 14, November 20 and December 13, 1973. The liability trial was conducted on February 19, 1974. During a recess in that trial, appellees filed a motion for directed 3e33713323
