Arkansas AG Elaine Brooks Announces More Than \$150,000 in Campaign Finance Charges Jan 20, 2016 Statewide News Arkansas Attorney General Leslie Rutledge and Representative Kim Hendren of Springdale announce \$150,000 in charges related to campaign finance violations. Posted on Jan. 20, 2016 Press Release Attorney General Leslie Rutledge announced Monday that her office has filed seven charges against multiple defendants alleging violations of state election laws, specifically multiple violations of contribution limits. The charges and accompanying chart summarize more than \$150,000 in reported campaign violations. The charges result from an investigation conducted by the Attorney General's Office into the alleged illegal contributions, the scheme by which the alleged contributions were reported and, in some cases, accepted and/or disbursed, and the amounts of money allegedly obtained as a result of the scheme. The Attorney General's Office filed charges against three individuals and one PAC. The charges were filed in connection with separate elections held in 2014 in Pulaski County, District 30 in Lonoke County, and in Garland County, District 14. According to the charges, defendant Erica Vanover, of 710 Carlin in Fayetteville, is alleged to have improperly accepted at least three contributions totaling \$10,000. Defendant Ford Hampton, of 1108 E. Main in Fayetteville, is alleged to have made two contributions totaling \$2,800. Defendant Eddie L. Davis, of 2301 N. Fifth in Fayetteville, is alleged to have made two contributions totaling \$2,800. As a result of the Attorney General's Office's investigation, defendant CMI PAC, a political action committee, filed reports and paid at least \$150,000 in campaign contributions between August 2014 and January 2015. During that same period, defendant CMI paid \$4,650 to defendant Vanover and \$2,200 to defendant Hampton. The Attorney General's Office alleges that \$1,000 of those contributions was deposited in defendant Davis's campaign account. According to CMI's report, it has paid more than \$400,000 to candidates, of which approximately \$100,000 was disbursed to defendants Hampton and Davis and other defendants. In addition to the campaign finance violations, the Attorney General's Office has filed charges in Circuit Court for first-degree theft. The charges allege that a major donor, who is not a defendant in
