using the facts of the previous example about frank, assume that after frank's \$1,200 payment, he received a \$1,000 payment and \$500 in the following year. frank doesn't pay tax on the \$1,000 (second year) payment because \$1,000 of each annual pension payment is tax free. if frank and katie (father and daughter) choose to have the annuity payments made directly to the daughter, you cannot make any tax-free adjustments. if they choose to have the payments made directly to you, then all of the payments must be included as taxable income. if the daughter is under 18, then all of the payments will be tax free. however, for katie, the first \$5,600 of each annuity payment is tax free. the remaining \$5,600 of each payment is taxable income to her. however, if the annuity payments are made to your husband, the annuity is included in your income. because you are only entitled to \$2,600 per year ( $\$1,600 + \$1,000 = \$2,600$ ), your income tax is calculated by applying the tax-free exclusion to the annuity as follows: if the annuity payments are made to your husband, the annuity is included in your income. because you are entitled only to \$2,600 per year ( $\$1,600 + \$1,000 = \$2,600$ ), your income tax is calculated by applying the tax-free exclusion to the annuity as follows: after the lump sum is paid, the student's tax-free portion is based on the ratio of his investment in the contract (or the contract's total expected return) to the total sum of his investment in the contract (or contract's total expected return).

return to the general rule, and subtract the \$300 tax-free ( $\$600 - \$300$ ) portion from the \$1,200 total. this is frank's recovery of his net cost of the annuity. his \$1,200 payment is now taxable at the rate of 50% (50% of \$1,200 is \$600), since his \$600 tax-free amount is less than \$1,000. if frank decides not to refigure his tax-free amounts at his third year annuity payment, the

\$1,200 is all taxable. in this case, frank is better off with the 50% tax rate on the \$600 tax-free portion of his first annuity payment and the 25% tax rate on his net cost, since \$1,200 is taxed at 25% and \$600 is taxed at 50%. if frank continues to receive \$1,200, he has no choice but to continue to use the general rule. the \$600 tax-free portion of the annuity is used to increase the tax-free portion of each following annuity payment. since the first annuity payment is tax free, frank's

---

part is \$600. he may continue to receive \$1,200 and use \$600 of each annuity payment to increase his tax-free portion each year. this is frank's only choice until he recovers his entire investment. at the end of the fifth year, the tax-free part of each annuity payment is \$1,200, so frank can receive a final total of \$5,400. this is the amount he will tax free at the end of the fifth year. since \$1,200 is \$600 more than the \$1,000 total recovery, he

---
